<19th KPMC Flight guideline_players>

From this year, airfare support for players has changed a lot due to several reasons such as government budget cut, restriction for amateur sports players, and <u>importance of reciprocity relationship</u> for international organizations and events. Please find the below in depth.

[Two options to book the flight ticket]

- 1) Self-booking
- After the KPMC, you will receive the subsidy with bearing transfer fee by KBF. It is highly recommended to receive it through Paypal.

If you really need to receive it through international bank account, you should forward flight requirements to KBF in advance without any wrong information.

Please notice that all problems caused by wrong or non-information to prevent subsidy transfer should be responsible for you.

- 2) booking through the travel agency
- The agency will book it with your contact, and you should bear the rest fee after deducting the subsidy. The ticket fee could be different from your country's own, and the commission fee for the agency should be borne by you.

*Every player should check his/her email regularly in order to find any information and requirement from the organizer. If you don't check it over 7 days, it could be deemed to unable to contact.

[Regarding the airfare support and requests]

- 1) More support for the country having reciprocity relationship
- According to the direction from the superior authority, which emphasizes the importance of building reciprocity relationship, the countries/territories having built such a relationship with KBF within 3 years would be supported more by priority.

[List of countries/territories with reciprocity relationship]

- 1. Asia(5)
- ♦Class A(reciprocal support for international competitions or events)
 - Singapore, China, Japan
- Class B(reciprocal invitation for international competitions or events)
 - Kyrgyzstan, India
- 2. Europe (2)
- ♦Class A France, Germany
- ◆Class B None
- 3. Special support(1) Ukraine

**Any inquiry about international exchange(=reciprocal support) would be welcomed through kaba@kbaduk.or.kr.

- 2) Subsidy for economy class only
- If you book a flight ticket other than economy class, you should forward an estimate document of the economy class ticket to the organizer as the upgrade fee cannot be supported by KBF. You may not receive the support if you don't forward the requirement.
 - 3) Non-support for the private schedule
- KBF can only support the necessary route to participate in the KPMC. The fee for an individual schedule should be borne by the participant. If you forward the flight requirement including private schedule without any prior notice, the support would be impossible.

[Subsidy amount]

- Airfare for a round-trip ticket could be supported up to 50% ($60\sim70\%$ for reciprocity area) with a limitation as below. The support could increase afterwards in accordance with the budget.

⟨For instance of private schedule⟩

- 1) When you come to China from Europe, and go to Korea for the KPMC a week later
- : Private schedule included. Only the ticket from China to Korea and Korea to Europe could be supported.
- 2) When your flight stops Chian for a day, and go to Korea next day
- : Could be supported since the travel agency checks it and confirms that stopover is necessary.

⟨For instance of airfare support limitation⟩

- 1) round-trip ticket \$300 (Asia) \rightarrow \$150 subsidy (*50% of the airfare)
- 2) round-trip ticket \$400 (Asia) → \$185 subsidy (*limitation for Asian Group)
- 3) round-trip ticket \$600 (Europe_RA[A]) $\rightarrow \$420$ subsidy (*70% of the airfare)
- 4) round-trip ticket \$1,000 (Europe_RA[B]) \rightarrow \$530 \nearrow 1 (*1imitation for Europe_RA[B])

[Flight documents needed to forward]

All players should forward the requirements to KBF.

- 1) Flight ticket(=E-ticket) (*PDF format) *guest flight ticket also required
- 2) Flight requirements
- 3) copy of bank account (*only when you need transfer to a bank account)

- *If the flight ticket is not written in Korean or English, please tell the organizer about the itinerary, price, and other details via E-mail.
- *All problems caused by wrong or non-information to prevent subsidy transfer should be responsible for you.

⟨Caution: Exclusion from airfare support⟩

- 1) when required documents are not submitted by the deadline or the data is insufficient
- 2) when it is determined an appropriate flight ticket has been issued (e.g. manipulation of estimate sheets or including personal schedule, etc.)
- 3) when committing a serious crime during the timeframe
- 4) when significantly undermining own/others' dignity as a representative
